provided with EN 148-1 connection (Screw-in type) suitable for Screw- in Filters

By combining a very soft thermoplastic Elastomer body with a "hard body shell" this Half Mask offers the highest protection level that was only possible with Full Face Masks.

The cumbersome filter housing is now eliminated, making the mask smaller, lighter, with an unrestricted view and is naturally more ergonomic. The Protect 1000 can be effectively used or all facial shapes as it has a universal fit, due to the specially designed flexible nose bridge. The newly designed head harness, fitted with a non-slip binding, guarantees comfort, security and easy adjustment during donning.









The Protect 1000 Mask can be used with the complete range of Class one filters as per IS 15323 / "EN 14387" and Particulate filters as per IS 15322/EN 143 having standard connecting threads as per IS 14138 (I) / EN 148 (I). Together, the half mask and the respiratory filter forms a protective filter device against: harmful gases and vapours, particulate matter (airborne particulates such as dust, fumes and mist).

The mask is compatible with all filters having "EN 148 (I)" connection and weighing less than 300gms. JLD also manufactures imarked filters in a sturdy Aluminium body suitable for the Protect 1000.
